The proposal was presented by Dr. Neha Jaiswal and thoroughly discussed by the committee. Following suggestions and rectification were recommended:


- N-Acetyl Cysteine being a well known and safe nutraceutical, there is no ethical issue to go ahead with this study since it is not a drug trial.
- Size of samples should be modified. Number of patients in pilot study could be around 100 (50 in each group) and for the main study 500 (250 in each group).
- In view of the data of other studies of N-Acetyl Cysteine in COVID-19, dose of 600 mg per day may be changed to 600 mg twice a day with no problem in safety issue.
- How the drug will be stored? It should be clearly mentioned.
- The process of informed consent should be clearly documented.
- Approximate budget should also be provided with the proposal.

*With no other matter to discuss, the meeting was adjourned and the applicant was advised to resend the proposal after necessary amendments.*


*EC Chairperson and other EC members were duly informed about the information noted below and approval were sought for the same:-*
