


After seeing the Balance Sheet and Audit Report of the Mayank Welfare Society the actual Budget estimates for 2018-19 were discussed. A total receipt of 97.81 crore rupees is expected in this Financial Year. Against this receipt projected expenditure has been shown as 87.84 crores there by showing a profit of 9.97 crores. A separate allocation within the Budget for some activities was directed by the Vice Chancellor. These activities are Research Work, Sports and Cultural Activities and Academic Seminars. CFAO was requested to put up revised Budget estimate.

For utilization of budget it was decided that a midterm review of the Budget position will be done in October every year. Corrections may be made looking to the actual positions.

The committee discussed the justification of fees increasing. The present system of preparing statements for recommendation of increasing fees was found to be satisfactory.




The minutes of the previous meeting were discussed.
