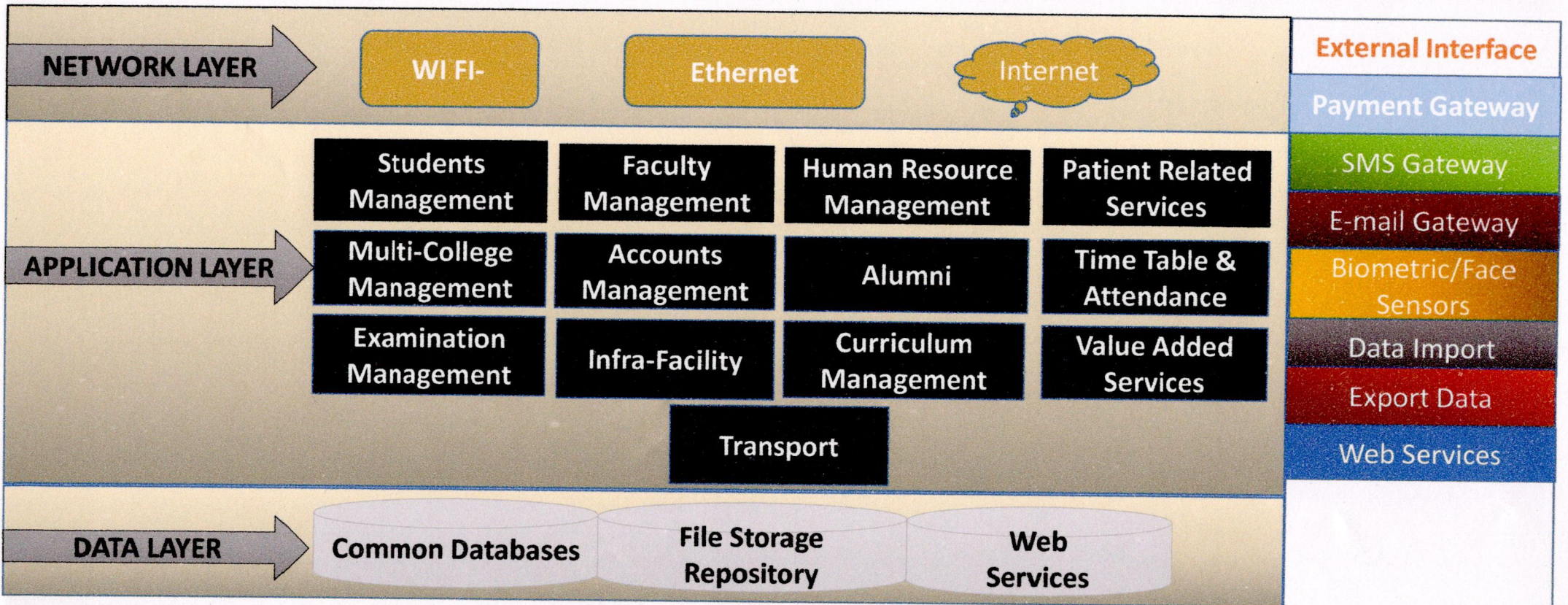

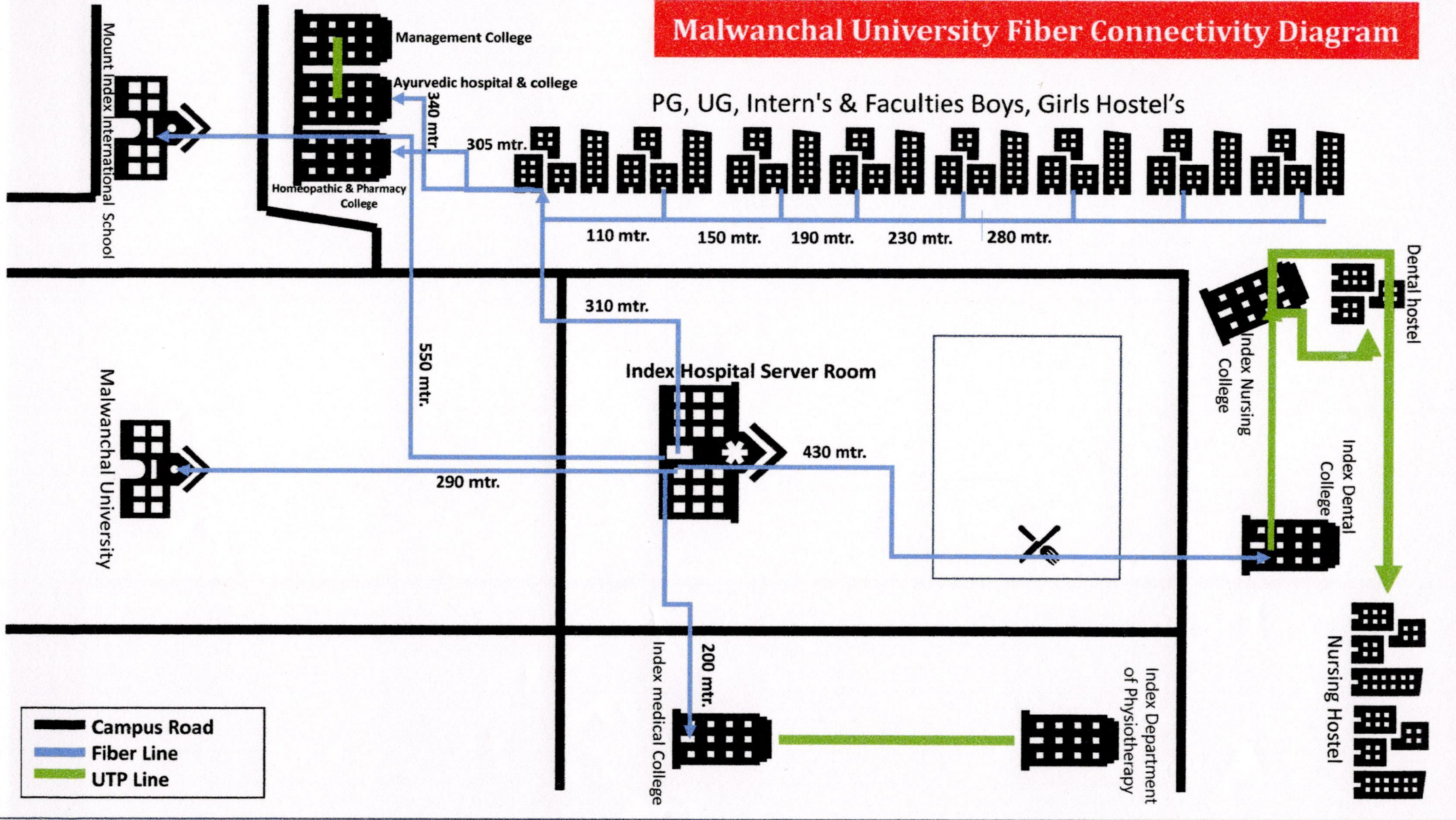

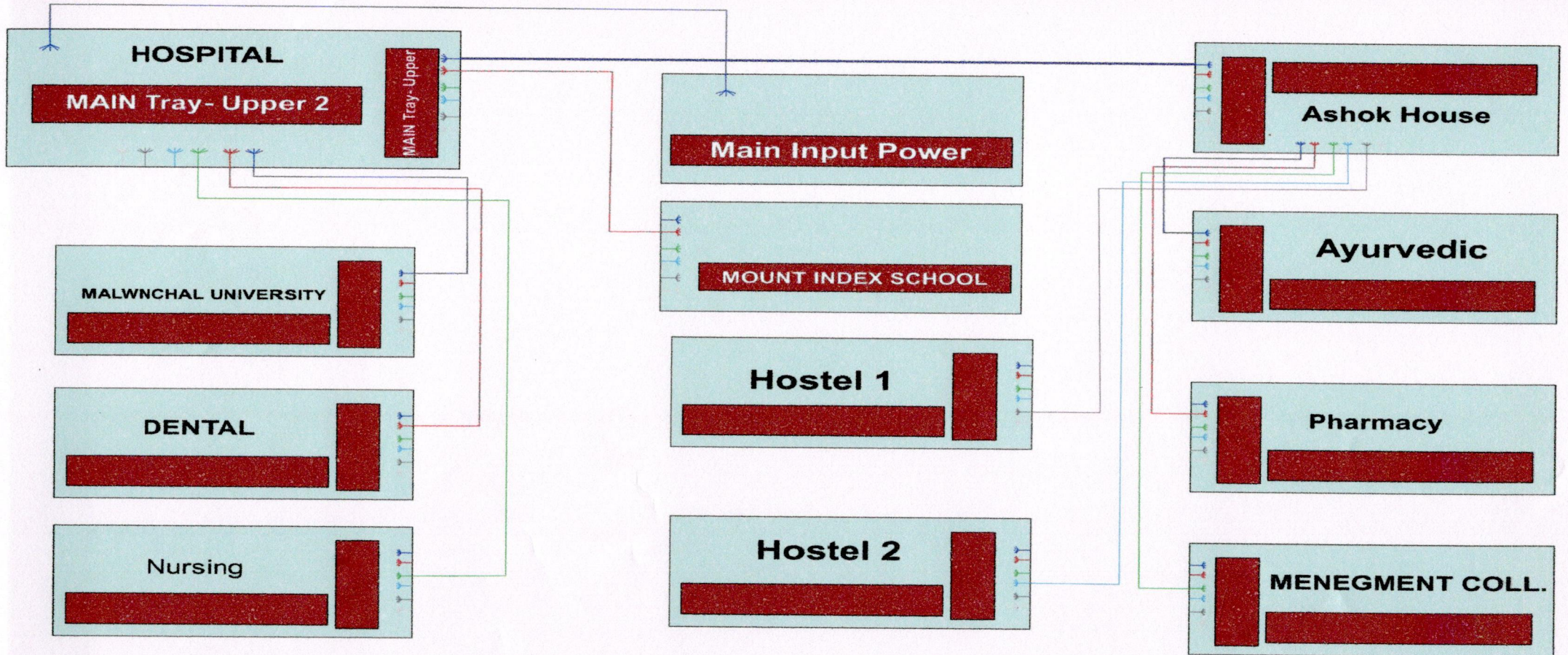

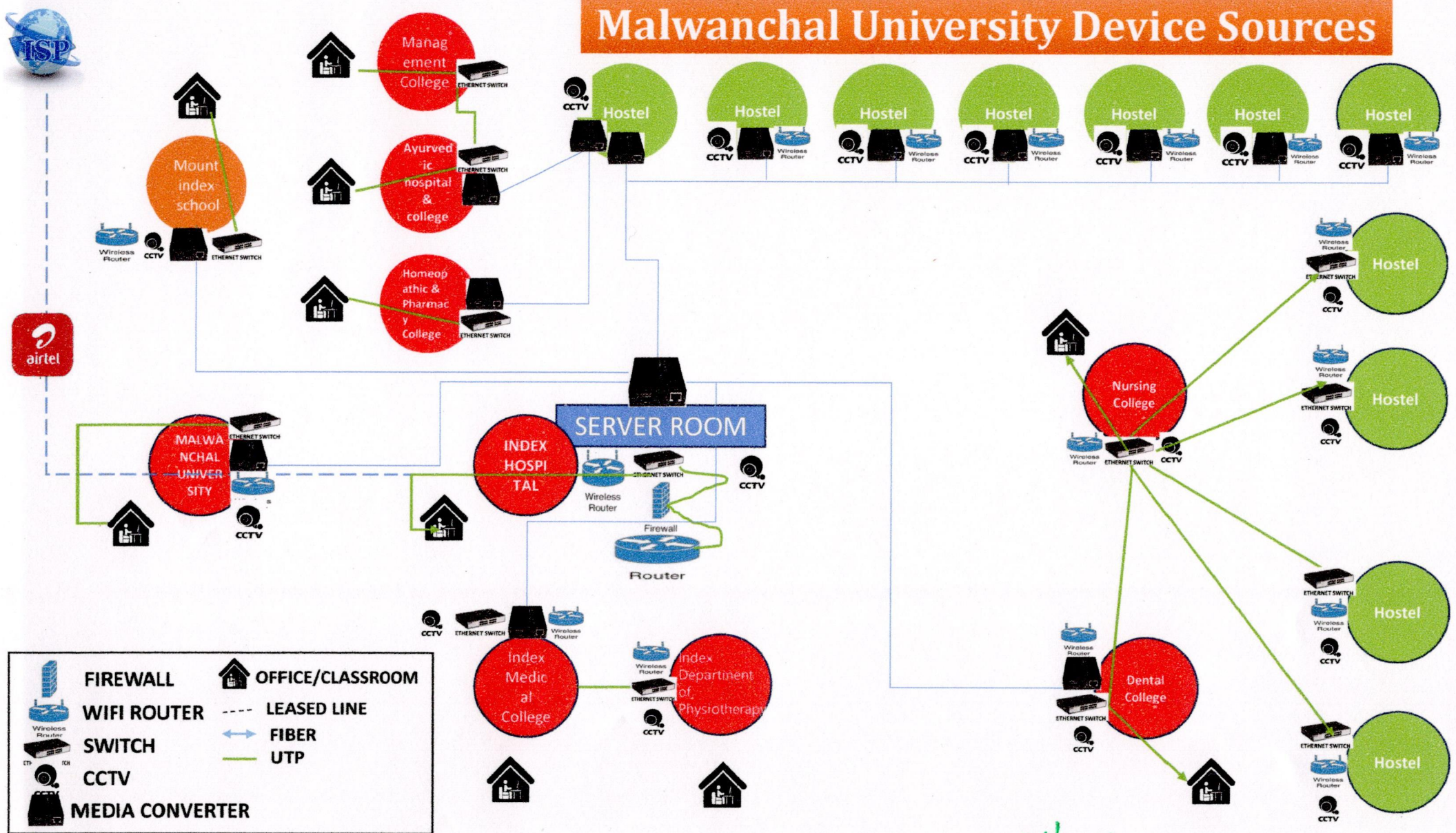
FIBER SPLICING NETWORK

- From IT Department, the network is distributed to all constituent LAN links via 1 GBPS Fiber Uplinks.

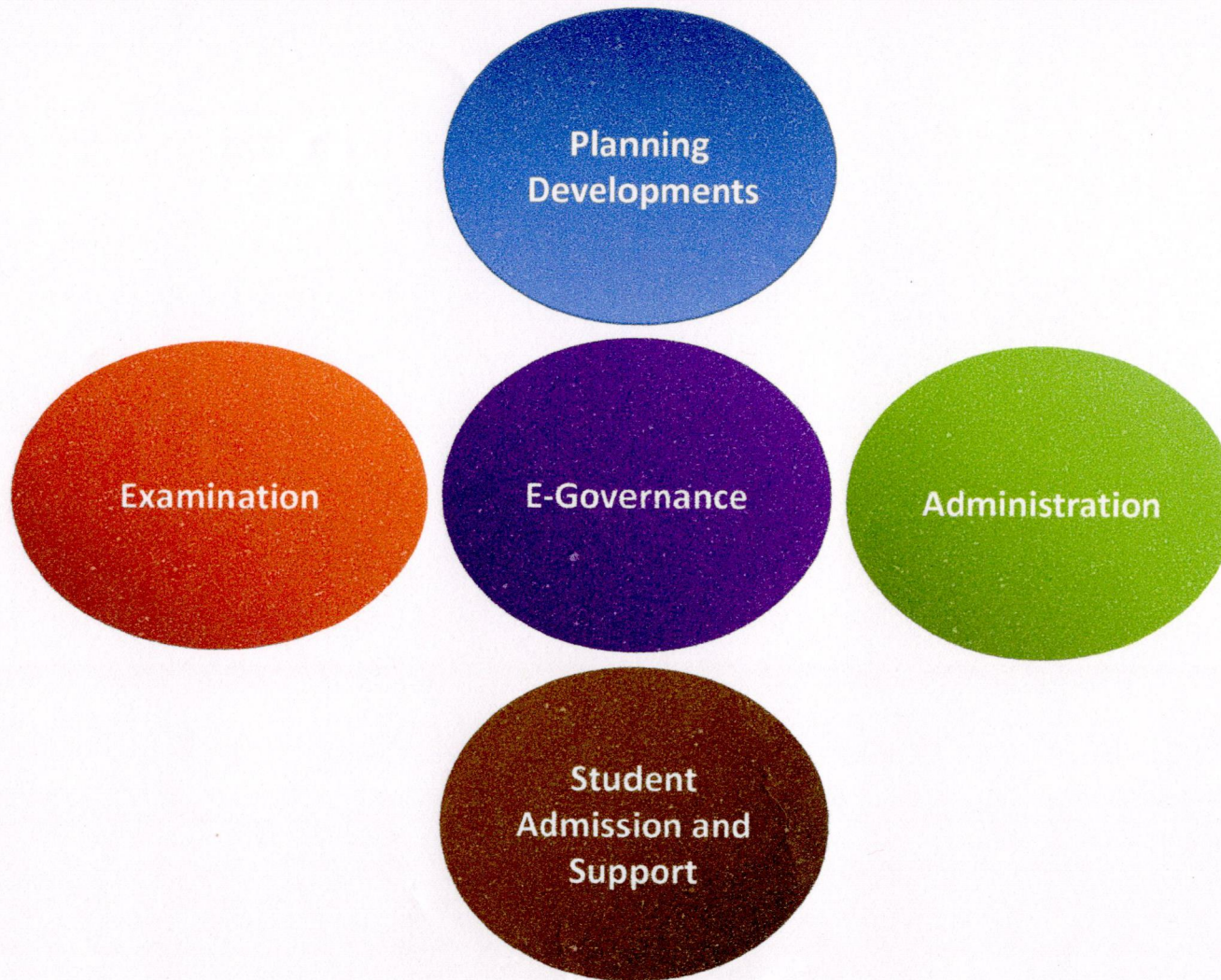


